



Industrial design fees

State fees for **Industrial design** proceedings should be paid to the **bank accounts of the Ministry of Finance**:

- SEB Pank EE571010220229377229 (SWIFT: EEUH22XX)
- Swedbank EE062200221059223099 (SWIFT: HABA22XX)
- Luminor Bank EE221700017003510302 (SWIFT: NDEA22XX)

When paying the state fees, a **unique reference** number provided by the Estonian Patent Office should be used.

If the state fees have already been paid or will be paid during filing the application before the Patent Office has provided a reference number, the reference number field should be left blank. In that case the data concerning the payment should be submitted to the Patent Office ([vastuvoett \[at\] epa.ee](mailto:vastuvoett[at]epa.ee)).

Amounts paid to these accounts appear in e-Tax Board on the account of state fees and returns.
