Tööstusomandi apellatsioonikomisjon, koosseisus Margus Tähepõld (eesistuja), Evelyn Hallika ja Sulev Sulsenberg, vaatas kirjalikus menetluses läbi välismaise juriidilise isiku Pivotal Payments Corporation (esindaja volikirja alusel patendivolinik Martin Jõgi) vaidlustusavalduse kaubamärgi **GLOBALONE + kuju** (rahvusvaheline reg nr 1262754) registreerimise vastu klassides 9, 35, 36, 38 ja 45 Globalone Management Group Limited nimele.

Asjaolud ja menetluse käik

1) 05.12.2016 esitas Pivotal Payments Corporation, 1100 Boul. René-Lévesque West 9th Floor, Montreal, Quebec H3B 4N4, *Kanada* (edaspidi ka *vaidlustaja*) tööstusomandi apellatsioonikomisjonile (edaspidi ka *komisjon*) vaidlustusavalduse, milles vaidlustatakse kaubamärgi **GLOBALONE + kuju** (rahvusvaheline reg nr 1262754) registreerimine klassides 9, 35, 36, 38 ja 45 Globalone Management Group Limited, MDE's Building, 1st Floor, P.O. Box 3169, PMB 257, Road Town, VG1110 Tortola, *Briti Neitsisaared* (edaspidi ka *taotleja*) nimele. Vaidlustusavaldus võeti menetlusse 16.12.2016 nr 1690 all ja eelmenetlejaks määrati Margus Tähepõld.

Eesti Patendiamet on teinud otsuse registreerida kaubamärk GLOBALONE + kuju (rahvusvaheline reg nr 1262754, registreeringu kuupäev 19.12.2014) taotleja nimele klasside 9, 35, 36, 38 ja 45 kaupade ja teenuste tähistamiseks. Teade õiguskaitse andmise otsuse kohta avaldati Eesti Kaubamärgilehes nr 10/2016.

Vaidlustaja, olles varasema kaubamärgi GLOBALONE omanik, ei ole andnud taotlejale luba kaubamärgi GLOBALONE + kuju registreerimiseks.

Kaubamärgiseaduse (edaspidi ka *KaMS*) § 10 lg 1 p 2 kohaselt ei saa õiguskaitset kaubamärk, mis on identne või sarnane varasema kaubamärgiga, mis on saanud õiguskaitse identsete või samaliigiliste kaupade või teenuste tähistamiseks, kui on tõenäoline kaubamärkide äravahetamine tarbija poolt, sealhulgas kaubamärgi assotsieerumine varasema kaubamärgiga.

Vaidlustaja kaubamärgitaotlus on esitatud 04.07.2014. Taotleja kaubamärgi prioriteedikuupäev pärineb 25.11.2014 ning registreeringu kuupäev 19.12.2014. Taotleja õigus on vaidlustaja kaubamärgist seega hilisem.

Vaidlustaja kaubamärk koosneb üksnes sõnast GLOBALONE. Taotleja kaubamärk koosneb sõnast **GLOBALONE** ning sellele lisatud kujundelemendist . Mõlema osapoole kaubamärki eristab seega esmajoones sõna GLOBALONE. Eeltoodust tulenevalt leiab vaidlustaja, et tema ja taotleja kaubamärgid visuaalselt äärmiselt sarnased ning foneetiliselt ja semantiliselt identsed.

Vaidlustaja kaubamärgiga tähistatakse klasside 9 ja 16 kaupu ning klassi 36 teenuseid. Taotleja kaubamärgiga tähistatakse klassi 9 kaupu ning klasside 35, 36, 38 ja 45 teenuseid. Mainitud kaubad ja teenused on vaidlustaja hinnangul identsed ning sarnased.

Euroopa Kohtu kohaselt eksisteerib äravahetamise tõenäosus, kui tarbijad võivad käsitada eri kaubamärkidega tähistatud tooteid samalt või majanduslikult seotud isikutelt pärinevatena (29.09.1998 otsus asjas C-39/97 Canon, p 29).

Tarbijatel on seejuures harva võimalust võrrelda kaubamärke külj-külje kõrval, nad peavad usaldama oma ebatäpset mälu pilti varasemalt nähtud märkidest (eelmainitud Euroopa Kohtu 22.06.1999 otsus asjas C-342/97 Lloyd Schuhfabrik Meyer, p 25). Kehtib ka põhimõte, et mida sarnasemad on kaubamärgid, seda erinevamad peavad olema nende kaubad ja teenused (Canon, p 17).

Arvestades kaubamärkide GLOBALONE ja GLOBALONE + kuju kõrget sarnasuse astet ning nendega tähistatavate kaupade ja teenuste identsust ja sarnasust, võib keskmine tarbija ekslikult leida, et:

- taotleja kaubamärgiga GLOBALONE + kuju tähistatav kaup või teenus pärineb vaidlustajalt, varasema kaubamärgi GLOBALONE omanikult,
- taotleja kaubamärgiga GLOBALONE + kuju tähistatav kaup on valmistatud või teenust pakub vaidlustajaga seotud firma, nt tütarettevõte,
- taotleja kaubamärgiga GLOBALONE + kuju tähistatava kauba või teenuse kvaliteet on tagatud vaidlustaja, varasema kaubamärgi GLOBALONE omaniku poolt.

Vaidlustaja hinnangul võib keskmine tarbija seega leida, et kaubamärkide GLOBALONE ja GLOBALONE + kuju kaubad või teenused pärinevad samalt isikult või et nende omanike vahel on äriline seos. Selles seisnebki *KaMS* § 10 lg 1 p 2 äravahetamise ja assotsieerumise tõenäosus.

Kaubamärgi GLOBALONE + kuju ja selle klassi 9 kaupade ning klasside 35, 36, 38 ja 45 teenuste osas esineb *KaMS* § 10 lg 1 p 2 sätestatud õiguskaitse andmist välistav asjaolu.

Vaidlustaja leiab, et arvestades kaubamärkide sõnaliste osade GLOBALONE identsust ning taotleja kaubamärgi kujundelemendi iseseisva eristusvõime puudumist, võib apellatsioonikomisjon *iura novit curia* põhimõttest tulenevalt rakendada identsete kaupade-teenuste osas ka *KaMS* § 10 lg 1 p 1.

KaMS § 10 lg 1 p 3 kohaselt ei saa õiguskaitset kaubamärk, mis on identne või sarnane varasema registreeritud või registreerimiseks esitatud kaubamärgi või valdavale enamusele Eesti elanikkonnast tuntud kaubamärgiga, millel on õiguskaitse teist liiki kaupade või teenuste tähistamiseks, kui hilisema kaubamärgiga võidakse ebaausalt ära kasutada või kahjustada varasema kaubamärgi mainet või eristusvõimet, mis oli omandatud hilisema kaubamärgi registreerimise taotluse esitamise kuupäevaks või prioriteedikuupäevaks.

Vastavalt ülaltoodule on taotleja õigus kaubamärgile GLOBALONE + kuju hilisem vaidlustaja õigusest kaubamärgile GLOBALONE.

Vastavalt ülaltoodule leidis vaidlustaja, et osapoolte kaubamärgid on visuaalselt äärmiselt sarnased ning foneetiliselt ja semantiliselt identsed.

Erialases praktikas on tõdetud KaMS § 10 lg 1 p 3 rakendatavust nii identsete/samaliigiliste kui ka eriliigiliste kaupade-teenuste osas. Seda toetab ka õigusteoreetiline seisukoht – kui õiguskord kaitseb kaubamärki selle maine ja/või eristusvõime kahjustamise ja/või ärakasutamise eest eriliigiliste kaupade-teenuste osas, siis peab kaitse olema tagatud ka identsete/sarnaste kaupade-teenuste osas. Ehk KaMS § 10 lg 1 p 3 on kohaldatav nii juhul, kui apellatsioonikomisjon peab kaubamärkide GLOBALONE ja GLOBALONE + kuju kaupu-teenuseid identseteks/ samaliigilisteks, kui ka juhul, kui neid peetakse osaliselt või terviklikult eriliigilisteks.

Taotleja kaubamärgi GLOBALONE + kuju kasutamine võimaldab taotlejal säästa uue ja eristusvõimelise kaubamärgi väljatöötamise arvelt aega ja raha, kasutades seejuures ära varasema kaubamärgi eristusvõimelise ja hea mainega kuvandit. Kui pakutavate GLOBALONE + kuju kaupade-teenuste kvaliteet ei vasta seejuures vaidlustaja kaupade-teenuste kvaliteedile, võidakse varasema GLOBALONE kaubamärgi eristusvõimet ja head mainet ka kahjustada.

Vaidlustaja leiab, et kaubamärgi GLOBALONE + kuju ja selle klassi 9 kaupade ning klasside 35, 36, 38 ja 45 teenuste osas esineb KaMS § 10 lg 1 p 3 sätestatud õiguskaitse andmist välistav asjaolu.

Vaidlustaja kaubamärk GLOBALONE on varasem taotleja kaubamärgist GLOBALONE + kuju. Kaubamärgid on visuaalselt väga sarnased ning foneetiliselt ja semantiliselt identsed. Nendega tähistatakse identseid ja samaliigilisi kaupu-teenuseid ning nende äravahetamine ja assotsieerumine on tõenäoline (KaMS § 10 lg 1 p 2). Lisaks sellele võib hilisema GLOBALONE + kuju kaubamärgi kasutamine kahjustada ja/või ära kasutada varasema GLOBALONE kaubamärgi head mainet ja/või eristusvõimet, seda nii identsete/samaliigiliste kui ka eriliigiliste kaupade-teenuste osas (KaMS § 10 lg 1 p 2).

Kõigele eeltoodule tuginedes, lähtudes KaMS §-dest 10 ja 41, tööstusomandi õiguskorralduse aluste seaduse (edaspidi ka TÕAS) §-dest 39, 43 ja 44 ning viidatud Euroopa Kohtu praktikast, palub vaidlustaja apellatsioonikomisjonil tühistada Patendiameti otsus registreerida kaubamärk GLOBALONE + kuju (rahvusvaheline registreering nr 1262754) klassi 9 kaupade ja klasside 35, 36, 38 ja 45 teenuste osas Globalone Management Group Limited nimele ning kohustada Patendiametit jätkama menetlust apellatsioonikomisjoni otsuses toodud asjaolusid arvestades.

2) Komisjon edastas 16.12.2016 vaidlustusavalduse Patendiametile, palvega teavitada taotlejat vaidlustusavaldusest ja määrata endale esindaja hiljemalt 16.03.2017. Taotleja ei ole endale tähtjaks esindajat nimetanud ega kasutanud oma õigust menetluses osaleda.

3) Vaidlustaja esitas 29.05.2017 oma lõplikud seisukohad, milles jäi oma varasemalt esitatud seisukohtade juurde.

4) Komisjon alustas 11.08.2017 asjas 1690 lõppmenetlust.

Komisjoni seisukohad

Komisjon, hinnanud menetluses esitatud seisukohti ja esitatud tõendeid, leiab järgmist.

Taotleja ei ole endale esindajat nimetanud, menetluses aktiivselt osalemise õigust kasutanud ega vaidlustaja seisukohtadele vastuväiteid esitanud. Ei saa eeldada, et taotleja, kes kogu komisjoni menetluse jooksul ei ole esitanud ühtegi vastuargumenti vaidlustaja seisukohtadele, üldse soovib neile vastu vaielda. Tulenevalt TÕAS § 51 lg-st 4 ja § 54¹ lg-st 5 ei ole see, et taotleja ei ole vaidlustusavaldusele vastanud ega esitanud komisjonile vaidlustusavalduse kohta seisukohti, käesolevas asjas otsuse tegemist takistavaks asjaoluks.

Vaidlustaja leiab, et kaubamärgi GLOBALONE + kuju registreerimine taotleja nimele klassi 9 kaupade ja klasside 35, 36, 38 ja 45 teenuste osas on vastuolus KaMS § 10 lg 1 punktidega 2 ja 3.

KaMS § 10 lg 1 p 2 kohaselt ei saa õiguskaitset kaubamärk, mis on identne või sarnane varasema kaubamärgiga, mis on saanud õiguskaitse identsete või samaliigiliste kaupade või teenuste tähistamiseks, kui on tõenäoline kaubamärkide äravahetamine tarbija poolt, sealhulgas kaubamärgi assotsieerumine varasema kaubamärgiga.

KaMS § 10 lg 1 p 3 kohaselt *ei saa õiguskaitset kaubamärk, mis on identne või sarnane varasema registreeritud või registreerimiseks esitatud kaubamärgi või valdavale enamusele Eesti elanikkonnast tuntud kaubamärgiga, millel on õiguskaitse teist liiki kaupade või teenuste tähistamiseks, kui hilisema kaubamärgiga võidakse ebaausalt ära kasutada või kahjustada varasema kaubamärgi mainet või eristusvõimet, mis oli omandatud hilisema kaubamärgi registreerimise taotluse esitamise kuupäevaks või prioriteedikuupäevaks.*

Vaidlustaja on vastandanud talle kuuluva Ühenduse kaubamärgi GLOBALONE (nr 013054135), taotluse kuupäev 04.07.2014, millel on õiguskaitse klasside 9 ja 16 kaupade ja klassi 36 teenuste osas. Vaidlustatud kaubamärgi GLOBALONE + kuju (RV reg nr 1262754) rahvusvahelise registreeringu kuupäev on 19.12.2014. Seega on vaidlustaja Ühenduse kaubamärk taotleja kaubamärgist varasem.

Kaubamärkide äravahetamise tõenäosuse hindamisel tuleb arvesse võtta kõiki tegureid, mis on asjakohased juhtumi asjaoludega. Üldine hinnang kaubamärkide visuaalse, foneetilise ja kontseptuaalse sarnasuse üle peab tuginema kaubamärkide üldmuljele, arvestades nende eristavaid ja domineerivaid komponente.

Komisjon nõustub vaidlustajaga selles, et vastandatud kaubamärkide domineerivaks ja eristusvõimeliseks osaks on märkide identne sõnaline element GLOBALONE. Käesoleva vaidluse objektiks oleva kombineeritud kaubamärgi kujunduses kasutatav kujundelement ei ole nii meeldejääv, et tarbija võiks kaubamärkide eristamisel hakata sellest lähtuma.

Komisjon nõustub ka vaidlustusavalduses toodud muude argumentidega võrreldavate kaubamärkide, kaupade ja teenuste sarnasuse kohta ja sellega, et vaidlustusavalduses toodud asjaoludel võivad tarbijad võrreldavaid kaubamärke segamini ajada KaMS § 10 lg 1 p 2 mõttes või et taotleja kaubamärgiga võidakse ära kasutada varasema kaubamärgi mainet ja eristusvõimet KaMS § 10 lg 1 p 3 mõttes. Komisjon ei pea vajalikuks vaidlustaja põhjendusi korrata. Taotleja ei ole komisjonile esitanud vaidlustaja põhjendusi ümberlukkavaid või kahtluse alla seadvaid seisukohti ega tõendeid.

Käesolevas asjas ei ole tuvastatud asjaolusid, mis välistaksid vaidlustusavalduse rahuldamata jätmise vaatamata asjaolule, et taotleja ei ole vaidlustusavaldusele vastuväiteid esitanud. Lähtudes kõigest eeltoodust kuulub vaidlustusavaldus rahuldamisele.

Tulenevalt eeltoodust, võttes aluseks TÕAS § 61 lg-d 1 ja 2, KaMS § 10 lg 1 p-d 2 ja 3 ning § 41 lg 3, komisjon

o t s u s t a s:

vaidlustusavaldus rahuldada, tühistada Patendiameti otsus kaubamärgi GLOBALONE + kuju” (RV reg nr 1262754) registreerimise kohta Globalone Management Group Limited nimele ning kohustada Patendiametit jätkama menetlust komisjoni otsuses toodud asjaolusid arvestades.

Vaidlustusavalduse menetlusosaline, keda ei rahulda komisjoni otsus ja kes soovib jätkata vaidlust menetlusosaliste vahel hagimenetluse korras, võib esitada hagi teise menetlusosalise vastu kaubamärgi õiguskaitset välistava asjaolu või selle puudumise kindlakstegemiseks kolme kuu jooksul apellatsioonikomisjoni otsuse avaldamisest arvates. Hageja teavitab viivitamata komisjoni hagi esitamisest.

Kui hagi ei ole esitatud, jõustub komisjoni otsus kolme kuu möödumisel otsuse avaldamisest ja kuulub täitmisele.

Kui hagi esitatakse, kuid kohus ei võta hagi menetlusse, jätab hagi läbi vaatamata või lõpetab menetluse otsust tegemata, jõustub komisjoni otsus vastava kohtumääruse jõustumise hetkest, kui kohtumäärusest ei tulene teisiti.
